The security deposit shall be held by Paddlecraft as security for the safe return of the hired equipment in the same condition when hired (fair wear & tear excepted). In the event of the hired equipment is returned in a state other than when hired or the equipment is lost or stolen during the period of hire, the security deposit will be forfeited to Paddlecraft and the hirer shall be further responsible for all additional costs of the damage or the cost of replacement. Return of the equipment beyond the period of hire will also incur a further hire fee at the current hourly full day or weekly rate.

**TERMS AND CONDITIONS**

**HIRER**

The Hirer will, if not paid in advance, pay Paddlecraft for the hire of the kayak and all equipment upon return. The Hirer acknowledges that the kayak and all accessories are at the hirer's risk for the duration of the hire period. The Hirer warrants that he / she shall not leave the waters as marked on the map displayed at the store. The Hirer further warrants that she / he will obey all rules applicable to kayaks and such equipment hired by the hirer in relation to the hirer's conduct of such kayak and equipment as provided by any authority whatsoever. In this regard, the Hirer shall not moor the kayak or equipment to any moorings, buoys, wharfs, jetties, pontoons or any structure whatsoever. The Hirer is specifically precluded from dragging or moving the kayak or any equipment over rocks or oysters. Damaged occasioned by a breach of any of these conditions will result in immediate forfeiture of the security deposit.

**INSURANCES**

Paddlecraft warrants that it will insure all kayaks for full retail value. Any excess payable by Paddlecraft whatsoever, as a result of the hirer's breach of terms and conditions of the hire herein, shall result in the hirer paying the excess, pursuant to such insurance, at such rate as it may be from time to time. Failure to return any equipment renders the hirer liable to pay the full cost of unreturned equipment at the current market rate.

The hirer specifically acknowledges that Paddlecraft will not be responsible for any personal injury occasioned to the hirer and any party that may occur in any manner whatsoever for the duration of the hire period. Paddlecraft advises the hirer that personal insurance is available to the hirer at an additional fee, for the period of the hire. The hirer fully indemnifies Paddlecraft, its officers and employees from any liability whatsoever as a result of damage to person or property occasioned during the hire period and acknowledges that hire of the kayak and equipment is at the risk of the hirer.

THIS DOCUMENT ALSO ADVISES THE HIRER(S) THAT PADDLECRAFT KAYAKS HAS INSURANCE COVER IN THE EVENT THAT INJURY OR LOSS IS SUSTAINED. IN THE EVENT THAT NEGLIGENCE ON THE PART OF THE HIRER(S) RESULTS IN INJURY OR LOSS THE HIRER(S) IS NOT COVERED BY PADDLECRAFT'S INSURANCE.
